2 The information we collect:

2.1 Members:

We may hold, your photograph (you have the right to refuse permission), and details on previous bookings, together with any preferences you may share with us.

2.2 Guests and Supporters:

Our database may contain your name, title, home address, email address and phone numbers so we can contact you with information relating to Manchester Luncheon Clubs Events. If you have chosen to pay by BACS, we will hold those details for processing purposes only. We may hold, your photograph (you have the right to refuse permission), and details on previous bookings, together with any preferences you may share with us.

2.3 Speakers:

We collect basic information such as name, address, telephone number, email address, quotes, emails. We may hold, your photograph (you have the right to refuse permission), and details on previous bookings, together with any preferences you may share with us.

2.4 Administration Team:

We hold details of your name, address, phone number and email address.

2.5 Suppliers:

We collect basic information such as name, address, telephone number, email address, quotes, emails.

3. How we use information and data:

We process bookings by telephone, email, and post. Processing may display your name, address, email address and Menu Choice. We hold your personal details in our records in case we need to contact you.

3.1 Members:

We will send you regular bulletins via email or post with news about the Club and our future Events. We may contact you by telephone if there is a problem or changes to an Event you are booked to attend. Your photograph may appear on our website or other publicity relating to any Event or future Event you may attended.

3.2 Guests and Supporters:

We will use your information to send you newsletters, by post, or emails to give you details of future Events, that are likely to be of interest to you. Your photograph may appear on our website or other publicity relating to any Event you attended. Please be aware that our website, newsletters, and publicity are public documents of the Manchester Luncheon Club.

3.3 Speakers:

We will use your information as and when required to contact you for Manchester Luncheon Club matters related to your involvement with us. Your photograph may appear on our website or other publicity relating to any future Event you may attended.

3.4 Administration Team:

Will use your information as and when required to contact you for matters related to your involvement with the Manchester Luncheon Club.

3.5 Suppliers:

We will use your information as and when required to contact you for matters related to your involvement with the Manchester Luncheon Club.

4. Security:

We put in place reasonable security measures to protect against any unauthorised access, damage, disclosure, or loss of, your information.
